We have also held talks with the Ambassador of USA, South Korea and the High Commissioner of Australia on investment cooperation initiatives.

We are also creating greater awareness of BIDA's online One Stop Service portal. We are urging businesses use the OSS to access speedy and transparent investor services, and to thereby participate in the Government's efforts to ensure a smooth environment for availing services related to starting and operating business in Bangladesh. As part of this effort, we have held a dissemination workshop with the Dhaka Chamber of Commerce and Industry (DCCI) to inform its members about the benefits of using BIDA's OSS.

As per the instruction of the Honorable Prime Minister, and under the guidance of the Private Industry and Investment Adviser to HPM, BIDA is leading the Government's initiative to ensure safer factories. Our stakeholders will be happy to know that more than 5,000 factories have already been inspected under the supervision of a 22-member national committee.

As we go forward, we will remain committed to support the sustainable growth of businesses in Bangladesh, and ensure for them an improved business environment.

In his speech, the Executive Chairman, BIDA told that both organizations had been together to facilitate working investment in the private sector. "Officially, China has been one of the major development partners of Bangladesh. Although Bangladesh received a huge investment from the government of China, Chinese investment in the private sector is much lower. Many Chinese private investors are now investing overseas. We have to make use of this opportunity," he said.

DVS, developed by the ICAB, will allow BIDA to verify the authenticity of audited financial statements of different entities.

Speaking on the occasion, the Executive Chairman, BIDA told that the DVS would help BIDA ensure transparency and accountability while registering new business entities. "We want to ensure transparency everywhere, for which use of such tools are essential," he said. It will also help BIDA approve new project proposals by investors, establishing their overseas office, remittance transfer and approve credit from foreign sources with greater transparency. The ICAB President told that the success of DVS depends on business groups, auditors and other stakeholders. ICAB would provide all out support regarding the DVS to the users.

Foreign investors can check the audited financial statements of a company before making a decision for cross boarder investment. The DVS will ensure the authenticity of this audited financial statements which will ultimately reduce the number of loan defaulters and bring confidence for foreign investment, he said and added that it would also enhance the revenue and thereby change the financial eco-system of the country. Introduced in December 2020, DVS is now being used by different regulatory bodies including the National Board of Revenue (NBR).

# More than 5,000 factories inspected for safety compliance: BIDA

As per the instructions of Honorable Prime Minister. **BIDA** currently leading government's factory inspections initiative. With the exception of ready-made garments (RMG), a committee has been set up to look into the environmental condition and safety of the remaining factories. There has been a 22-member national committee aimed at preventing accidents and ensuring a safe working environment, headed by Mr. Salman Fazlur Rahman, MP, Private Industry and



### BIDA's OSS help businesses save cost and time

Mr. Md Sirazul Islam, Executive Chairman, BIDA was the Chief Guest at a dissemination workshop on OSS, hosted by the DCCI in its auditorium in Dhaka held on April 20, 2022. Mr. Rizwan Rahman, President, DCCI Chaired the event, while Ms. Mohsina Yasmin, Executive Member, BIDA, among others, were present at the event.

Dhaka Chamber of Commerce and Industry (DCCI) hosted a dissemination workshop on the BIDA's OSS on April 20, 2022 at its auditorium in Dhaka. The event as chaired by Mr. Rizwan Rahman, President, DCCI and Mr. Md Sirazul Islam, Executive Chairman, BIDA graced the event as the Chief Guest. Speakers at the programme stressed the need for popularizing the one-stop service (OSS) of BIDA to help businesses save cost and time.

Mr. Md Sirazul Islam, Executive Chairman, BIDA informed the audience that 58 different services are being provided through the OSS portal which should be availed by the private sector proactively. Addressing the audience, he further told that BIDA's registration and name clearance from the Registrar of Joint Stock Companies and Firms (RJSC) can now be done

within 24 hours through OSS. At present, 90-per cent BIDA services are being given in time as more than 60,000 services have been provided under the OSS in the past three years, he adds. The BIDA can further include hundreds of services to its OSS upon demand from the private sector. "If we can reduce time and process," Mr. Islam says, "cost will automatically come down."

Mr. Rizwan Rahman, President, DCCI underlined the importance of a changed mindset of businesses regarding to the use of the OSS. He assured that the DCCI would work to disseminate the positive features of the OSS to its members as well as to the business community to make it popular. Ms. Mohsina Yasmin, Executive Member, BIDA; Mr. Arman Haque, Senior Vice-president, DCCI and Mr. Monowar Hossain, Vice-president, DCCI, among others, spoke at the programme.





