Message from the new Executive Chairman



I offer my deepest gratitude to the Hon'ble Prime Minister Sheikh Hasina MP for appointing me as the Executive Chairman of Bangladesh Investment Development Authority (BIDA) and entrusting me with the important responsibilities that this organization has to deliver. I feel honored and elevated to have this opportunity to serve the country from a different perspective.

Bangladesh has emerged as one of the world's most attractive frontier economies supported by strong leadership, socio-political stability, steady growth, a massive domestic market, prudent fiscal policies and a resilient recovery from the Covid-19 pandemic. Private investment plays the pivotal role in driving the nation's progress, and its importance is emphasized in the Hon'ble Prime Minister's Special Initiative Biniyog Bikash, which translates to Investment Promotion.

To become a middle-income country by 2031 and a developed country by 2041, Bangladesh is promoting high-value investment in its emerging sectors with the aim to diversifying the economy, creating knowledge-based employment, adopting new technologies and boosting export. As per the 8th Five Year Plan, our immediate goal is to raise the share of private investment from 23% to 27.35% of the GDP by 2025. Foreign Direct Investment (FDI) has also to be increased to 3% of the GDP. As the apex Investment Promotion Agency (IPA) of Bangladesh under the Prime Minister's Office, BIDA works with multiple stakeholders to create new investment opportunities and ensure higher participation of the private sector in the country's economy and to achieve those stated targets.

Since its establishment, BIDA has been the first gateway for investors in Bangladesh. It performs this role as promoter and facilitator of private investment and also as the lead advocate of business-friendly policies. As a regulator, BIDA has set the standard for delivering time-bound and transparent services through its online One Stop Service (OSS) portal - the country's first-interoperable platform for investor services. The scopes and service qualities of this platform will be extended further gradually.

In the coming days, BIDA will deepen its efforts to attract quality investments – both domestic and foreign, ensure comfort of existing investors and strengthen coordination with all relevant stakeholders to holistically improve the country's business climate. BIDA will also work with global partners to strengthen its capacity to deliver crucial IPA services.

On this note, I invite our partners to take this journey with us for the fulfillment of the goals to secure success and prosperity of Bangladesh.

BIDA organized a discussion on the occasion of the National Mourning Day 2022. The meeting was chaired by Ms. Mohsina Yasmin, Executive Member, BIDA and Mr. Md. Sirazul Islam, Executive Chairman, BIDA attended the event as Chief Guest.

BIDA has observed the National Mourning Day and the 47th martyrdom anniversary of the Father of the Nation Bangabandhu Sheikh Mujibur Rahman and most of his family members.

A discussion on the life and ideals of the Father of the Nation was organized along with a prayer meeting at the BIDA Multipurpose Hall on Aug 15, 2022. Ms. Mohsina Yasmin, Executive Member, BIDA, chaired the event while Mr. Md. Sirazul Islam, Executive Chairman, BIDA, joined as Chief Guest.

The assassinations of Aug 15, 1975 attempted to delete Bangladesh's history and misrepresent the Father of the Nation, said BIDA Executive Chairman. "When I began my career, working in various Government departments, I realized that Bangabandhu developed plans for every sector in just the three and a half years that he governed war-torn Bangladesh. Today, his plans are being implemented under the visionary leadership of his daughter Prime Minister Sheikh Hasina," he said.

Be excellent in the disposal of your duties, he told BIDA officials. "This is the only way you can fulfil your debt to Bangabandhu."

Several others including Mr. Avijit Chowdhury, Executive Member (Strategic Investment), Mr. Md. Matiur Rahman, Executive Member (Marketing and Communication), Mr. Mohammad Arifur Rhaman, Director, BIDA and Mr. Md. Maruful Alam, Deputy Director, contributed in the discussion.

He has a Master's degree in History from Dhaka University. He has participated in training in both Bangladesh and abroad and in multiple specialized areas including Law and Administration, Survey and Settlement, Land Administration, Advanced Administration and Development. He has also taken part in training Military courses by the Bangladesh Academy (BMA).

He has visited many countries on official duty and for training including South Korea, UK, USA, Canada, Turkey, China, New Zealand, Finland, Switzerland, India, Thailand, Malaysia, Philippines, Vietnam, Indonesia, Sweden, Netherlands, France and Germany.

He was born on June 15, 1963 at Gournadi Upazila of Barishal District.

Indian companies to invest BDT 800 crores: BIDA EC



BIDA organized a Media Briefing event on August 28, 2022 at BIDA conference Hall on the outcomes of a recent conference titled "Trade and Investment Prospects between India and Bangladesh". Mr. Md Sirazul Islam, Executive Chairman, BIDA briefed the media.

Indian companies have expressed their interest in investing BDT 800 crores in Bangladeshi joint ventures, BIDA Executive Chairman Md. Sirazul Islam has said during media briefing.

The briefing on Aug 28, 2022 at BIDA conference Hall was organized to share the outcomes of an investment conference in India titled "Trade and Investment Prospects between India and Bangladesh".



The conference was organized jointly by the Bangladesh Investment Development Authority (BIDA), the Confederation of Indian Industry

(CII) and the India-Bangladesh Chamber of Commerce and Industry (IBCCI) on August 23, 2022 in Jaipur, India.

Indian investors expressed their interest in investing in Tata diesel generators, mustard oil production, marble and granite cutting and polishing industry, silver, gold and handmade products and tourism business in Bangladesh.

TVS Motors will invest BDT 300 crore with Nitol-Niloy Group in Bangladesh to build three-wheeler cargo vehicles and Credinox Impex Private Limited will invest BDT 300 crore in setting up a mustard oil factory. Indian companies will also invest in jewelry and a paper factory.

"The conference was able to generate deep interest of participants. As many as, nine Memorandums of Understanding (MoUs) and Expressions of Interest (EoIs) were signed between parties, mostly for joint ventures". The enthusiasm has witnessed in Jaipur has led him to believe that the Hon'ble Prime Minister's visit to Delhi in September 2022 would create higher interest among Indian investors, he added.

Mr. Abdul Matlub Ahmad, President, IBCCI, said, "Currently, Bangladesh exports about \$2 billion worth of goods to India. To reduce the trade gap, we are working to increase the exports to \$3 billion and boost Indian investments in Bangladesh." IBCCI Vice President M Shoeb Chowdhury was also present on the occasion.




