5 new services added to BIDA OSS

BIDA has integrated five new investor services with its online One Stop Service (OSS) Portal. The new services were officially launched through a ceremony at BIDA conference room on October 31, 2022.

The new services are E-mutation by Ministry of Land, No Objection Letters for proposed and existing industries by Department of Fire Service and Civil Defence, Water Connections for industries by Dhaka WASA and Land Use Permit by Rajdhani Unnayan Kartipakkha (RAJUK).

Mr. Saifuzzaman Chowdhury MP, Hon'ble Minister, Ministry of Land, joined the ceremony as Chief Guest. He said integrating the Land Ministry's services with BIDA OSS would simplify the process of setting up industries. "Enhancing investor services will lead to higher volumes of FDI for Bangladesh, which is very important for our economy. No country can develop without FDI. So, we must provide integrated investment services."

Mr. Lokman Hossain Miah, Executive Chairman, BIDA, presided over the event. "Following the integration of the new services, BIDA OSS has 63 services of 23 agencies including BIDA. BIDA has observed the 59th birthday of Sheikh Russel, the youngest son of Father of the Nation Bangabandhu Sheikh Mujibur Rahman, who was martyred at the age of ten along with most members of his family.

This year's slogan for the day translates to 'Sheikh Russel is a Symbol of Serenity, Spiritedness and Courage.' (Sheikh Russel Nirmolotar Pratik, Duranto Pranobanto Nirbhik)

Youngest brother to the Honorable Prime Minister Sheikh Hasina, Sheikh Russel was born on October 18 in 1964 at Bangabandhu Bhaban at Dhanmondi 32 in Dhaka. He was brutally killed during the assassination of his father Bangabandhu Sheikh Mujibur Rahman and family members on August 15, 1975.

To observe his birthday, BIDA officials placed floral wreaths in front of Sheikh Russel's portrait at BIDA office. A discussion chaired by BIDA Executive Member Ms. Mohsina Yasmin and graced by BIDA Executive Chairman Mr. Lokman Hossain Miah as Chief Guest was organized later during the day.

A special prayer was said at the beginning of the discussion for Sheikh Russel and all martyrs of the August 15 assassinations in 1975.

A virtual meeting of the US-Bangladesh Labor Working Group was held on October 27, 2022.

Mr. Salman Fazlur Rahman, MP, Private Industry and Investment Adviser to Hon'ble Prime Minister led the Bangladeshi side and Mr. Jose W Fernandez, Under Secretary for Economic Growth, Energy, and Environment, led the US delegations at the inaugural meeting of the working group.

Mr. Lokman Hossain Miah, Executive Chairman (Senior Secretary), BIDA; Mr. Shaikh Yusuf Harun, Executive Chairman (Senior Secretary), BEZA; Md Ehsan-E-Elahi, Secretary, Ministry of Labor and Employment, Mr. Muhammad Imran, Bangladesh Ambassador to the United States; Major General Abul Kalam Mohammad Ziaur Rahman, Executive Chairman BEPZA; H.E. Mr. Peter Haas, US Ambassador to Bangladesh and other high-level representatives from relevant departments joined the meeting.

The objective of the meeting was to support Bangladeshi implementation of commitments to improve labor rights protections and to further economic cooperation between the US and Bangladesh.

Bangladesh and the US discussed "collaboration and assistance" to Bangladesh as it takes further steps to implement the requirements developed by Bangladesh for its International Labor Organization roadmap and adhere to internationally recognized labor rights.

Mr. Salman Fazlur Rahman detailed steps the government has taken to develop the labor sector. He said that Bangladesh considers also the recommendations of the United States of America, the European Union, and the International Labor Organization (ILO) on labor rights with due importance. The US team leader Mr. Fernandez praised the steps taken to develop the labor sector in Bangladesh and called for the full implementation of the recommendations of the ILO. He pledged to provide necessary cooperation and work together for the further development of the labor sector of Bangladesh.

Major reform initiatives accelerated as 10th NCMID meeting held

The 10th meeting of the "National Committee for Monitoring Implementation of Doing Business Reforms (NCMID)" meeting was chaired by Cabinet Secretary Mr. Khandkar Anwarul Islam at the Cabinet Division on October 04, 2022. The Prime Minister's Private Industry and Investment Adviser, Executive Chairman of BIDA, senior secretaries and secretaries representing the Prime Minister's Office, Legislative and Parliamentary Affairs Division, the Power Division, Public Security Division of the Ministry of Home Affairs and the Ministry of Public Administration, Ministry of Housing and Public Works, Local Government Division, Ministry of Shipping, Ministry of Environment, Forests and Climate Change, Ministry of Land, Security Services Division of the Ministry of Home Affairs, Ministry of Commerce, Law and Justice Division were, among others, present in the meeting.

Major decisions taken during 10th NCMID Meeting:

- ✓ CDA will integrate its "Occupancy Certificate" service with BIDA OSS within next week.
- ✓ RAJUK will integrate its 04 services with BIDA OSS within 28 February 2023.
- ✓ FSCD will integrate its 03 services- (1) Fire License-New, (2) Fire License-Renewal (3) NOC for high-rise building construction with BIDA OSS within December 2022.
- ✓ Trade License-Renewal service provided by the Dhaka South City Corporation (DSCC), Dhaka North City Corporation (DNCC) and Chattogram City Corporation will integrate with BIDA OSS within February 2023.
- ✓ NBR will automate Corporate Tax Return and Tax-Revise system within next 06 months. To complete this automation process NBR will arrange various seminar-workshop within the stakeholders' institution.
- ✓ Trade License will be issued for 05 Years from all city corporation/municipalities/union parishad and Local Government Division will issue Office Order regarding this.


